AVAILABLE INTERNSHIPS

Investigations

Investigations interns collect and review evidence for police misconduct investigations, draft interview questions, participate in interviews, and assist with special projects.

Public Affairs

Public affairs interns develop communication and outreach materials, plan and participate in community outreach events, create website content, and establish media contacts.

Law

Law clerks conduct legal and policy research, write legal memoranda on police misconduct related issues, attend agency complaint examination hearings, and participate in meetings with government and police department officials.

WHAT WE DO

The Office of Police Complaints (OPC) is a government agency that receives, investigates, and resolves complaints from the public alleging police misconduct, including claims of discrimination, excessive force, harassment, and unprofessional language and conduct. The agency is independent of the police departments it investigates.

OPC also issues policy recommendations that focus on reducing police misconduct through better training, supervision, and discipline of police officers, as well as improving the citizen complaint process.

In addition, OPC conducts outreach, trainings, and presentations for a variety of audiences throughout the District of Columbia metropolitan area. OPC also participates in community forums, festivals, town hall meetings, and other events to educate the public about the agency's mission and services.

ADVANTAGES OF THE INTERNSHIP PROGRAM

GENERAL REQUIREMENTS

- Summer interns must commit to working 40 hours per week, and generally receive a stipend as the budget allows
- Spring and fall interns must commit to working at least 16 hours per week
- Spring and fall internships are unpaid, but can be done in conjunction with a course for academic credit

HOW TO APPLY

Please submit a resume and a cover letter describing your interest in the program and specifying which internship you are applying for. Each internship also requires a writing sample.
